SUMMARY

1. In 2024 there were (6) Burial Interments and (10) Cremation Interments
2. A total of (1) graves and 1 niches were purchased.
3. We performed (1) inurnment in the columbarium last year.
4. Decoration Day was held on the customary date which is the second Sunday of August 2024. Decoration Day was advertised in the LFP on Saturday August 3 and Saturday August 10.
I led the service in the church at 3 p.m.
We received a total of \$1,363.00 in donations on that day.

COLUMBARIUM AREA & FUTURE SCATTERING GARDEN

1. There has been inquiries regarding a scattering garden as an economical option and green option.
2. The Board of Directors continue discussions regarding this. The Diocese does not have guidelines but the BAO does and are in consultation with them.

PRICES

1. As the cemetery manager, I continue to price check twice a year to ensure that our prices reflect the average prices that are being charged city-wide.
2. The BAO increased their fees per internment in July 2023 under the Consumer Protection Fee. Since then, a \$30 fee is added to the opening and closing charge of a grave and has to be paid to them.
3. The Cemetery is now set up for cash, cheques and E-transfers.

RECORD KEEPING

1. We continued to computerize cemetery records and maps and scan all existing documents into electronic files, ensuring that they smoothly link to the current "*Stone Orchard*" cemetery and mapping software which we use.
2. As reported already last year, the Diocese of Huron, requires the cemetery to store both paper files, past and present, as well as a digital copies of all files. The digital copies must be stored on the "*Cloud*" online storage system which can be accessed by Diocese of Huron, the Rector, Administrator, Cemetery Board.

It is therefore vital that these records are up-to-date at all times which is an on-going process.

3. The remastering of the Master map is continuing as this involves checking the layout and do an on-site measuring and verifying. The purpose of the remastering is to ensure that the layout maximizes the available space in the cemetery.

A digital version of the Master map will be produced. This allows for easy access in regards to graves available for purchase as well for grave buy-backs.

The digital Master map is a very effective way to keep the ever-changing information up-to-date. A new computer system is in the works

WEBSITE FOR ST. JOHN'S CEMETERY, ARVA

The Diocese of Huron approved the website for St. John's Cemetery, Arva and the link for the website will be forwarded in the coming months to be included in the St. John's Arva Church website for easy access.

The most recent Google search performed by me shows St. John's Cemetery, Arva as a separate item from the church.

It would be far more advantageous for Anglicans and existing members of St. John's Arva church and Non-Denomination alike to have a tab for the cemetery included in the menu of the church's website.

INVESTMENTS

All investments were reviewed prior to their due date and funds were then either re-invested or cashed in. Once GIC from Scotia McLeod was closed out and moved to TD to be invested.
